**Local Governmental Units - Elections (November 8, 2022)**

**3. L22-143 - Acadia Parish, Crowley Service Area Fire Protection District No. 11**

\$100 parcel fee, 10 years, 2023-2032, acquiring, constructing, maintaining and operating fire protection facilities and equipment, including the cost of obtaining water for fire protection purposes and all purposes incidental.

**4. L22-149 - Acadia Parish, Fire Protection District No. 8**

\$75 parcel fee, 10 years, 2023-2032, acquiring, constructing, maintaining and operating fire protection facilities and equipment.

**5. L22-130- Acadia Parish Police Jury, Sales Tax District No. 2**

1% sales tax, 15 years, beginning April 1, 2027, **(1)** repairing, constructing, improving and maintaining roads and bridges in the unincorporated areas of the Parish, including incidental drainage in connection therewith and **(2)** acquiring equipment.

**6. L22-121 - Allen Parish Police Jury**

**(1)** 4.0 mills tax, 10 years, 2023-2032, improving, maintaining and supporting the Courthouse and Jail; **(2) Fire Protection District No. 1** - 6.47 mills tax, 10 years, 2023-2032, **(a)** constructing, improving, maintaining and operating the fire protection facilities, including the acquisition of fire trucks and paying the cost of obtaining water for fire protection purposes, and **(b)** any charges for fire hydrant rentals and services; **(3) Road District No. 5** - 5.30 mills tax, 10 years, 2023-2032, constructing, operating and maintaining Parish roads and bridges.

**7. L22-122 - Avoyelles Parish Police Jury**

**(1)** 7.0 mills tax, 10 years, 2023-2032, providing garbage and solid waste collection and disposal; **(2)** ¼% sales tax, to be levied in perpetuity, beginning January 1, 2023, providing garbage and solid waste collection and disposal.

**8. L22-127 - Bienville Parish Law Enforcement District**

10.91 mills tax, 10 years, 2024-2033, additional funding.

**9. L22-126 - Bossier Parish, South Bossier Fire District No. 2**

3.50 mills tax, 15 years, 2023-2037, **(1)** acquiring, constructing, improving, maintaining or operating fire protection and emergency medical service facilities, vehicles and equipment, including both movable and immovable property, including paying the cost of obtaining water for fire protection purposes and salaries of firemen and **(2)** all purposes incidental.

**10. L22-155 - Caddo Parish Commission**

(1) 4.74 mills tax, 10 years, 2024-2033, acquiring, equipping, constructing, improving, maintaining and operating (including acquisition of library books, material and equipment) the public library system, including branches; (2) 4.66 mills tax, 10 years, 2024-2033, (a) 4.21 mills dedicated to maintaining and operating (including acquisition of library books, materials and equipment) the public library system and (b) 0.45 mills dedicated to the payment of mandated costs of the Criminal Justice System; (3) 5.52 mills tax, 10 years, 2024-2033, (a) 5.10 mills dedicated to maintaining, equipping and operating Parish Detention Facilities and (b) 0.42 mills dedicated to the payment of mandated costs of the Criminal Justice System; (4) 5.96 mills tax, 10 years, 2024-2033, (a) maintaining, operating and repairing roadways, bridges, garbage disposal and industrial waste facilities, surface water drains and drainage facilities and (b) payment of mandated costs of the Criminal Justice System; (5) 1.30 mills tax, 10 years, 2024-2033, (a) 1.09 mills dedicated to maintaining and operating public health units, mosquito and rodent control units, and animal control facilities and (b) 0.21 mills dedicated to the payment of mandated costs of the Criminal Justice System; (6) Not exceeding \$20,000,000 General Obligation Bonds, in one or more series, not exceeding 8%, not exceeding 20 years, expansion and renovation of the Walter B. Jacobs Nature Park and other capital improvements, together with acquiring all necessary land, equipment and furnishings.

**11. L22-117 - Calcasieu Parish Police Jury**

3.49 mills tax, 10 years, 2024-2033, (1) maintaining and operating the Juvenile Detention Center and Juvenile Probation Office, (2) paying the costs of improvement to or construction of facilities at the Juvenile Detention and (3) providing and/or contracting for the provision of juvenile care, shelter, evaluations, treatment and counseling services.

**12. L22-118 - Calcasieu Parish Police Jury**

2.48 mills tax, 10 years, 2024-2033, (1) maintaining and operating the facilities and services of the Parish Health Unit, (2) improvement or construction of health facilities, and (3) providing and/or contracting for health-related services and responsibilities under the authority of the Police Jury.

**13. L22-119 - Calcasieu Parish Police Jury**

4.06 mills tax, 10 years, 2024-2033, (1) paying the cost of expenses, equipment and supplies related to construction, hardsurfacing and improving roads, highways, and bridges, and the necessary ditching and drainage; (2) continuation of a road and drainage trust fund in the amount of \$1,000,000 annually to be appropriated to projects which have local, state, or federal matching funds.

**14. L22-134 - Caldwell Parish School Board, Consolidated School District No. 1**

7.41 mills tax, 10 years, 2024-2033, giving additional support for current operations of the public schools.

**15. L22-132 - East Baton Rouge Parish, Central Fire Protection District No. 4**

(1) 10.0 mills tax, 10 years, 2025-2034, (a) development, operation and maintenance of the Fire District and (b) paying the costs of obtaining water for fire protection purposes, including charges for hydrant rentals and service and (2) 4.25 mills tax, 10 years, 2025-2034, salaries, retirement, benefits and related expenses.

**16. L22-145 - East Baton Rouge Parish, Metropolitan Council of the Parish of East Baton Rouge and City of Baton Rouge**

1.06 mills tax, 10 years, 2024-2033, (1) purchase, maintain and operate machinery, facilities and equipment necessary and useful in the eradication, abatement or control of mosquitoes, other arthropods of public health importance and rodents and (2) maintaining and providing for adequate administrative and support staff.

**17. L22-146 - East Baton Rouge Parish, Metropolitan Council of the Parish of East Baton Rouge and City of Baton Rouge, Brownsfield Fire Protection District No. 3**

10.0 mills tax, 10 years, 2024-2033, (1) development, improvement, operation and maintenance of the fire protection facilities, (2) paying salaries and benefits of fire district personnel, (3) paying the costs of obtaining water for fire protection purposes and (4) paying the cost of fire hydrant rentals and service.

**18. L22-131 - East Carroll Parish Police Jury**

(1) 8.24 mills tax, 10 years, 2023-2032, constructing, maintaining and administering public drainage and canals, ditches and other public drainage facilities; (2) 8.24 mills tax, 10 years, 2023-2032, constructing, maintaining and administering roads and bridges; (3) 2.0 mills tax, 10 years, 2023- 2032, acquiring, constructing, improving, maintaining and/or operating an enhanced 911 telephone system (including the payment of necessary dispatch personnel).

19. **L22-115 - Evangeline Parish School Board, School District No. 7, Second Police Jury Ward of Evangeline and Seventh Police Jury Ward of the Parish of Acadia**  
6.25 mills tax, 10 years, 2023-2032, operating, maintaining and improving public school facilities.
20. **L22-136 - Franklin Parish Police Jury**  
8.12 mills tax, 5 years, 2023-2027, maintaining, operating and purchasing equipment.
21. **L22-129 - Grant Parish, Hospital Service District, Ward 7**  
4.31 mills tax, 10 years, 2024-2033, maintenance and general expenditures needed in everyday operation and other miscellaneous expenses incurred in operation.
22. **L22-124 - Grant Parish, Village of Georgetown**  
2% sales tax, to be levied in perpetuity, beginning January 1, 2023, **(1)** 50% for acquiring, constructing, improving, maintaining and operating the waterworks system and sewerage system, including purchasing and acquiring land, equipment and fixtures necessary therefor and **(2)** 50% for any lawful purpose.
23. **L22-152 - Iberia Parish Council**  
¼% sales tax, 10 years, beginning August 1, 2023, **(1)** maintaining and operating a mosquito control program including acquisition of land, buildings and equipment necessary therefor and **(2)** the balance of proceeds to be divided annually between the Parish and the incorporated municipalities of the Parish on a per capita basis for constructing, acquiring and improving drainage facilities.
24. **L22-172 - Iberia Parish, City of New Iberia**  
6.83 mills tax, 20 years, 2023-2042, **(1)** constructing, improving, and maintaining public roads, streets, and bridges including drainage works, landscaping, and other improvements associated therewith, and **(2)** acquiring access and rights of way.
25. **L22-141 - Jefferson Davis Parish, Jefferson Davis Central Waterworks District**  
10.24 mills tax, 10 years, 2024-2033, acquiring, constructing, improving, maintaining or operating waterworks facilities.
26. **L22-120 - Lafourche Parish Council**  
Rededicate proceeds heretofore and hereafter collected for a 2.0 mills tax authorized through 2027, **(1)** providing funding for senior citizens' programs and services administered by the Lafourche Council on Aging, Inc./ Area Agency on Aging, including administrative costs; **(2)** acquiring, constructing, improving and maintaining building and facilities for use by the Agency.
27. **L22-169 - LaSalle Parish School Board, School District No. 1-A**  
**(1)** 5.10 mills tax, 10 years, 2024-2033, construction, improvements to existing schools, including additions, major repairs and renovations, or other capital improvements; **(2)** 5.10 mills tax, 10 years, 2024-2033, operation, maintenance, and improvement to the public schools.
28. **L22-168 - Natchitoches Parish, Fire Protection District No. 6**  
**(1)** 10.0 mills tax, 10 years, 2023-2032, **(a)** acquiring, constructing, improving, maintaining and/or operating fire protection facilities and equipment, including emergency equipment, **(b)** paying the cost of obtaining water for fire protection services, **(c)** paying salaries of firemen and **(d)** all purposes incidental thereto; **(2)** Not exceeding \$25 parcel fee, 10 years, 2023-2032, **(a)** acquiring, constructing, improving, maintaining and/or operating fire protection facilities and equipment, **(b)** paying the cost of obtaining water for fire protection services, **(c)** paying salaries of firemen and **(d)** all purposes incidental thereto.
29. **L22-147 - Orleans Parish, City of New Orleans**  
Amend Article IV, Section 4-106 of the Home Rule Charter to **(1)** require City Council confirmation of appointments by the Mayor or Chief Administrative Officer to head any executive branch department established by Article IV of the Charter, **(2)** to permit the City Council, by ordinance, to require confirmation of any appointment to head any other department, office or unit to which executive powers have been assigned or transferred in accordance with Sections 4-105 or 9-201(2) of the Charter and **(3)** to allow interim appointments of up to 120 days without first obtaining City Council confirmation, as provided in Ordinance No. 28999 M.C.S.
30. **L22-156 - Orleans Parish, City of New Orleans, Delachaise Security and Improvement District**  
Not exceeding \$300 parcel fee, 1 year, 2023, providing security and funding activities and improvements for the betterment of the District.

31. **L22-150 - Orleans Parish, City of New Orleans, Hurstville Security and Neighborhood Improvement District**  
Not exceeding \$575 parcel fee in the first year plus annual increases of \$25, 8 years, 2023-2030, promote and encourage security, beautification and overall betterment.
32. **L22-138 - Pointe Coupee Parish, Fire Protection District No. 2**  
4.40 mills tax, 10 years, 2023-2032, providing funds for salaries and benefits of personnel.
33. **L22-128 - Pointe Coupee Parish, Town of Fordoche**  
7.0 mills tax, 10 years, 2023-2032, general municipal and local purposes.
34. **L22-123 - Rapides Parish Police Jury**  
(1) **Road District No. 5A** - 40.0 mills tax, 10 years, 2023-2032, (a) constructing, maintaining, and keeping in repair the public roads, highway and bridges and (b) constructing and maintaining drainage roads; (2) **Road District No. 6A, Ward 6** - 30.16 mills tax, 10 years, 2023-2032, (a) construction and maintenance of road right-of-way fencing and (b) construction, maintenance and drainage of roads.
35. **L22-125 - Rapides Parish, Village of Forest Hill**  
½% sales tax, to be levied in perpetuity, beginning January 1, 2023, acquiring, constructing, improving, maintaining and operating the gas utility and distribution system, waterworks system, sewers and sewerage treatment and disposal facilities, including purchasing and acquiring land, equipment and fixtures necessary therefor.
36. **L22-133 - Richland Parish, Rural Fire District, Ward 1**  
6.55 mills tax, 10 years, 2023-2032, (1) acquiring, constructing, maintaining and operating fire protection facilities and equipment, including paying the cost of obtaining water for fire protection purposes and salaries of firemen and (2) all purposes incidental thereto.
37. **L22-159 - Sabine Parish Police Jury**  
(1) 4.0 mills tax, 10 years, 2022-2031, administration, improvement, operation, maintenance and support of the Parish Library and its branches, including costs of any capital improvements; (2) 0.25 mills tax, 10 years, 2022-2031, operation, administration, support and maintenance for the Parish Health Unit, including the costs of any capital improvements; (3) **Road District No.4, Ward 7** - 13.88 mills tax, 10 years, 2022-2031, (a) constructing, improving, maintaining and/or repairing public roads and bridges, including ditching and drainage and (b) purchasing equipment.
38. **L22-170 - St. John the Baptist Parish Council**  
(1) 1.0 mill tax, 10 years, 2023-2032, maintaining and operating public buildings used to house developmentally disabled persons, including payment of salaries and cost for conducting training programs for developmentally disabled persons; (2) 1.0 mill, 10 years, 2024-2033, (a) acquire, construct, maintain and operate Parish Senior Citizens' Centers and (b) funding other Parish Senior Citizens' Programs, operated by the Council on Aging, Inc.
39. **L22-157 - St. Landry Parish, Coulee Croche Gravity Drainage District No. 22**  
(1) 4.72 mills tax, 10 years, 2024-2033, constructing, improving, and maintaining gravity drainage works; (2) 4.50 mills tax, 10 years, 2023-2032, constructing, improving, and maintaining gravity drainage works.
40. **L22-151 - St. Landry Parish Council**  
(1) **Road District 11A, Sub-Road District No. 1** - 9.56 mills tax, 10 years, 2023-2032, improving, maintaining and operating public roads and bridges, including purchase of equipment; (2) **Road District 11A, Sub-Road District No. 2** - 8.43 mills tax, 10 years, 2023-2032, improving, maintaining and operating public roads and bridges, including purchase of equipment.
41. **L22-164 - St. Landry Parish Public Works Commission, District No. 5**  
15.0 mills tax, 10 years, 2024-2033, (1) constructing, acquiring, operating and maintaining the roads, bridges and road drainage facilities and (2) acquiring the necessary equipment.
42. **L22-142 - St. Mary Parish, City of Morgan City**  
0.30% sales tax, 12 years, beginning January 1, 2024, constructing, improving, resurfacing, maintaining and providing street drainage for public streets, alleys, sidewalks and public wharves, and acquiring equipment.

43. **L22-161 - St. Tammany Parish, Town of Pearl River**  
3.96 mills tax, 10 years, 2023-2032, improving streets.
44. **L22-137 - Tensas Parish, Gravity Drainage District No. 3**  
(1) 2.31 mills tax, 10 years, 2024-2033, maintaining drainage work; (2) 1.63 mills tax, 10 years, 2024-2033, maintaining drainage work.
45. **L22-135 - Union Parish, Sadie Tiger Bend Fire Protection District**  
\$50 parcel fee, 10 years, 2023-2032, (1) acquiring, constructing, maintaining and operating fire protection facilities, including the cost of obtaining water for fire protection purposes and (2) all purposes incidental.
46. **L22-171 - Union Parish School Board, Consolidated School District No. 1**  
15.0 mills tax, 10 years, 2023-2032, giving support to public elementary and secondary schools.
47. **L22-139 - Vernon Parish Police Jury, Road District No. 3**  
(1) 11.89 mills tax, 10 years, 2023-2032, maintaining roads and bridges; (2) 4.77 mills tax, 10 years, 2023-2032, constructing and improving roads and bridges.
48. **L22-144 - West Baton Rouge Parish School Board, Parishwide School District No. 3**  
15.0 mills tax, 10 years, 2024-2033, additional support to public elementary and secondary schools.
49. **L22-140 - Winn Parish, City of Winnfield**  
1½% sales tax, 10 years, beginning December 1, 2023, (1) sewer treatment, solid waste landfill, capital improvements, including streets, drainage and sanitation and (2) any other lawful purposes.

Not exceeding \$1,600,000 Sales Tax Bonds, not exceeding 6%, not exceeding 5 years, constructing, maintaining, and improving public streets.

(1) Not exceeding \$7,800,000 Water Revenue Bonds, approximately \$4,065,000 not exceeding 1.375%, approximately \$3,735,000 not exceeding 6%, not exceeding 40 years, constructing and acquiring additions, extensions and improvements to the water system, including but not limited to comprehensive improvements to its drinking water supply, treatment, distribution and storage facilities; (2) not exceeding \$7,800,000 Bond Anticipation Notes, not exceeding 5%, not exceeding 2 years, interim financing.
56. **L22-094 - Pointe Coupee Parish, Consolidated Sewerage District No. 1 (DEQ Project)**  
Not exceeding \$1,500,000 Sewer Revenue Bonds, not exceeding 2.45%, not exceeding 22 years, constructing and acquiring additions, extensions and improvements to the sewerage system, including equipment and fixtures.

**57. L22-162 - St. Tammany Parish, Fire Protection District No. 9**

Not exceeding \$1,400,000 Limited Tax Bonds, not exceeding 6%, mature no later than March 1, 2047, acquiring, constructing, and improving fire protection and emergency medical service facilities, vehicles and equipment.

Not exceeding \$18,000,000 Revenue Bonds, not exceeding 7.5%, not exceeding 40 years, **(1)** refinancing loans associated with the acquisition of land and the construction, equipping and furnishing of GEO Prep Academy, a kindergarten through eighth grade, tuition free, public charter school in Baton Rouge and **(2)** financing the acquisition, construction, renovation and equipping of a kindergarten through fourth grade facility, including the acquisition of land.

**61. S22-026 - Louisiana Public Facilities Authority (GEO Academies EBR - GEO Prep Mid City Project)**

Not exceeding \$19,000,000 Revenue Bonds, not exceeding 7.5%, not exceeding 40 years, **(1)** financing the acquisition, construction, renovation and equipping of GEO Prep Mid City, a kindergarten through eighth grade, tuition free, public charter school in Baton Rouge, including the acquisition of land, **(2)** funding a reserve fund and **(3)** paying capitalized interest.
