2. Approval of the minutes of the July 21, 2022 meeting.

Representative Scott McKnight, representing the Speaker of the House moved approval, seconded by Senator Franklin Foil, representing the President of the Senate and without objection, the minutes were approved.

### Local Governmental Units - Elections (December 10, 2022)

Ms. Folse provided a synopsis on Items 3 through 6.

#### 3. L22-187 - Calcasieu Parish, Chennault International Airport Authority

5.45 mills tax, 10 years, 2026-2035, industrial, commercial, and economic development purposes, including maintaining, operating, relocating, constructing, or improving industrial properties or airport facilities.

Representative Scott McKnight, representing the Speaker of the House moved approval, seconded by Senator Franklin Foil, representing the President of the Senate and without objection, the item was approved.

#### 4. L22-180 - East Baton Rouge Parish Law Enforcement District

6.90 mills tax, 10 years, 2024-2033, operational purposes.

Representative Scott McKnight, representing the Speaker of the House moved approval, seconded by Senator Franklin Foil, representing the President of the Senate and without objection, the item was approved.

#### 5. L22-183 - Morehouse Parish, City of Bastrop

(1) 2.56 mills tax, 20 years, 2024-2043, (a) acquiring, maintaining, and constructing playgrounds, recreation centers, and other recreational facilities, and (b) funding into bonds for capital purposes; (2) 3.23 mills tax, 20 years, 2024-2043, (a) operating, maintaining, improving and enlarging the existing fire protection system, and (b) funding into bonds for capital purposes; (3) 0.65 mills tax, 20 years, 2024-2043, (a) acquiring, maintaining, and operating public cemeteries, and (b) funding into bonds for capital purposes; (4) 0.65 mills tax, 20 years, 2024-2043, (a) constructing, maintaining, and improving public building, and (b) funding into bonds for capital purposes.

Representative Scott McKnight, representing the Speaker of the House moved approval, seconded by Senator Franklin Foil, representing the President of the Senate and without objection, the item was approved.

#### L22-182 - Morehouse Parish, City of Bastrop, Sales Tax District No. 1

1/2% sales tax, 10 years, commencing January 1, 2025, (1) maintaining, improving, repairing and extending the streets, sidewalks, alleys, roadways and related drainage, and (2) funding into bonds for capital purposes.

Representative Scott McKnight, representing the Speaker of the House moved approval, seconded by Senator Franklin Foil, representing the President of the Senate and without objection, the item was approved.

#### 7. L22-194 - East Baton Rouge Parish, St. George Fire Protection District No. 2

Not exceeding \$9,000,000 Revenue Bonds, not exceeding 4%, mature no later than August 1, 2023, current operations.

Representative Scott McKnight, representing the Speaker of the House moved approval, seconded by Senator Franklin Foil, representing the President of the Senate and without objection, the item was approved.

#### 8. L22-193 - Orleans Parish School Board

Not exceeding \$75,000,000 Revenue Anticipation Notes, not exceeding 6%, mature no later than June 29, 2023, current expenses.

Representative Scott McKnight, representing the Speaker of the House moved approval, seconded by Senator Franklin Foil, representing the President of the Senate and without objection, the item was approved.

#### 9. L22-181 - Plaquemines Parish Law Enforcement District

Not exceeding \$3,200,000 Certificates of Indebtedness, not exceeding 5%, mature no later than June 30, 2023, current expenses.

Representative Scott McKnight, representing the Speaker of the House moved approval, seconded by Senator Franklin Foil, representing the President of the Senate and without objection, the item was approved.

#### **Local Political Subdivisions - Loans**

#### 10. L22-190 - Beauregard Parish, South Beauregard Recreation District No. 2

Not exceeding \$4,500,000 Excess Revenue Certificates of Indebtedness, not exceeding 5%, not exceeding 10 years, acquiring, constructing, extending, or improving works of public improvement including but not limited to the construction of two additional baseball ballfields, a splash pad, certain lighting improvements, bleachers and facilities related thereto.

Ms. Folse provided a synopsis. Representative Scott McKnight, representing the Speaker of the House moved approval, seconded by Senator Franklin Foil, representing the President of the Senate and without objection, the item was approved.

#### 11. L21-127B - Allen Parish, Hospital Service District No. 3

(1) Not exceeding \$17,270,000 Hospital Revenue Bonds, Series 2023A, approximately \$13,170,000, Series 2023AR-1 & AR-2 and approximately \$2,600,000, Series 2023AR-3, not exceeding 2.25% for Series 2023AR-1 & AR-2, not exceeding 3.25% for Series 2023AR-3, not exceeding 30 years or not exceeding 40 years if bonds are sold to a governmental agency of the United States and approximately \$1,500,000 Taxable Hospital Revenue Bonds, Series 2023B, not exceeding 10%, not exceeding 25 years, (a) acquiring, constructing, renovating and improving facilities to provide emergency medical services, hospital buildings, and facilities, including building a new hospital, related health care and emergency medical facilities, and acquiring equipment and furnishings and (b) funding reserve funds, if required and (2) Not exceeding \$15,770,000 Bond Anticipation Notes, not exceeding 6%, not exceeding 2 years, interim financing.

Honorable Jeffrey Landry, Attorney General moved approval contingent upon (1) Verification of the amended certified resolutions adopted by the Allen Parish, Hospital Service District No. 3 and Allen Parish Police Jury authorizing an increase and adjustment to the par and interest rates of the bonds and BANs, which was adopted on August 16, 2022 and (2) Receipt of a commitment letter for remaining project financing, seconded by Senator Franklin Foil, representing the President of the Senate and without objection, the item was conditionally approved.

#### L22-192 - Caddo-Bossier Parishes Port Commission (Chasing Aces Project)

Not exceeding \$25,000,000 Taxable Revenue Bonds, not exceeding 7%, not exceeding 25 years, developing an entertainment complex in Bossier City for the benefit of the Chasing Aces Sports Entertainment, LLC.

Honorable Jeffrey Landry, Attorney General moved approval, seconded by Senator Franklin Foil, representing the President of the Senate and without objection, the item was approved.

# 13. L22-185 - Orleans Parish, City of New Orleans, Sewerage and Water Board of New Orleans (DEQ Project)

Not exceeding \$35,000,000 Sewerage Service Revenue Bonds, not exceeding 4%, not exceeding 22 years, capital improvements.

Additional information was provided by Mr. Jason Akers, Bond Counsel, Foley & Judell, LLP and Mr. Paul Rainwater, Lobbyist, City of New Orleans. After further discussion, Representative Scott McKnight, representing the Speaker of the House moved approval, seconded by Senator Franklin Foil, representing the President of the Senate and without objection, the item was approved.

### 14. L22-189 - DeSoto Parish Police Jury (International Paper Company Project)

Not exceeding \$5,000,000 Revenue Refunding Bonds, not exceeding 15%, fixed or variable, not exceeding 25 years, refunding Environmental Improvement Revenue Refunding Bonds, Series 2017A.

Ms. Folse provided a synopsis. Representative Scott McKnight, representing the Speaker of the House moved approval, seconded by Senator Franklin Foil, representing the President of the Senate and without objection, the item was approved.

#### 15. L22-186 - Orleans Parish, City of New Orleans

Not exceeding \$135,000,000 General Obligation Refunding Bonds, not exceeding 6%, mature no later than December 1, 2042, refunding General Obligation Bonds, Series 2012 and Taxable Public Improvement Bonds Series 2013A and 2014A.

Ms. Folse provided a synopsis. Additional information was provided by Mr. Jason Akers, Bond Counsel, Foley & Judell, LLP and Mr. Paul Rainwater, Lobbyist, City of New Orleans. After further discussion, Representative Scott McKnight, representing the Speaker of the House moved approval, seconded by Senator Franklin Foil, representing the President of the Senate and without objection, the item was approved.

#### **Local Political Subdivisions - Other**

#### 16. L22-191 - St. Tammany Parish, Hospital Service District No. 1

Approval to enter into a lease agreement between the District and Healthcare Properties LLC, not exceeding \$7,500,000 annual lease payments, not exceeding 20 years with an option to renew for not exceeding 20 years, relating to an ambulatory surgery center and obligations thereunder.

Ms. Folse provided a synopsis. Representative Scott McKnight, representing the Speaker of the House moved approval, seconded by Senator Franklin Foil, representing the President of the Senate and without objection, the item was approved.

#### 17. S20-045A - Louisiana Housing Corporation (Lotus Village Project)

Not exceeding \$1,000,000 Multifamily Housing Revenue Bonds (Volume Cap), not exceeding 8%, not exceeding 40 years, acquisition, construction and equipping of a 116-unit multifamily housing facility for seniors in Baton Rouge.

Representative Scott McKnight, representing the Speaker of the House moved approval contingent upon verification of a subsequent resolution by the Louisiana Housing Corporation (LHC) authorizing the additional principal, which was adopted on August 10, 2022, seconded by Senator Franklin Foil, representing the President of the Senate and without objection, the item was conditionally approved.

#### 18. S22-016A - Louisiana Housing Corporation (St. Claude Gardens II Project)

Not exceeding \$6,000,000 Multifamily Housing Revenue Bonds (Volume Cap), not exceeding 8%, not exceeding 40 years, acquisition, construction, and equipping of a 39-unit multifamily housing facility in New Orleans.

Representative Scott McKnight, representing the Speaker of the House moved approval contingent upon verification of a supplemental resolution by the Louisiana Housing Corporation (LHC) which was adopted on August 10, 2022, seconded by Senator Franklin Foil, representing the President of the Senate and without objection, the item was conditionally approved.

#### **Corporations**

#### 19. S21-011A - Louisiana Citizens Property Insurance Corporation

Not exceeding \$125,000,000 Line of Credit, not exceeding 6% variable rate, mature no later than June 1, 2023, paying insurance claims in the event that sufficient funds are not otherwise available.

Ms. Folse provided a synopsis. Additional information was provided by Mr. Adam Parker, Bond Counsel, Butler Snow, LLP, Mr. Richard Newberry, CEO, Louisiana Citizens Property Insurance Corporation, and Mr. Joe Sciortino, Vice-President of Accounting and Finance, Louisiana Citizens Property Insurance Corporation. After further discussion, Senator Bret Allain, Chair, Senate Revenue and Fiscal Committee moved approval, seconded by Representative Scott McKnight, representing the Speaker of the House and without objection, the item was approved.

Ms. Folse provided a synopsis. Additional information was provided by Mr. Jason Akers, Bond Counsel, Foley & Judell, LLP and Mr. Paul Rainwater, Lobbyist for the City of New Orleans. After further discussion, Representative Jerome Zeringue, Chair, House Appropriations Committee moved to defer Item 23 for another month to allow the representatives of the City, the Mayor and the Sheriff, to come before the Bond Commission to express their position in regards to the issue. The motion was seconded by Representative Scott McKnight, representing the Speaker of the House. There was an objection to the motion by Mr. Matthew Block, representing Governor John Bel Edwards. There was a Roll Call Vote and the results were 7 Yeas, 6 Nays and the motion passed.

#### 24. Virtual Meetings
