3. L22-228 - Lafourche Parish, Hospital Service District No. 1

Not exceeding \$15,000,000 Hurricane Recovery Revenue Bonds, not exceeding 5%, not exceeding 10 years, **(1)** demolition, rehabilitation, repair, reconstruction, renovation, restoration and improvement of properties and facilities resulting from or related to Hurricane Ida, including constructing a temporary hospital facility and purchasing any furnishings, fixtures and equipment incidental or necessary and **(2)** funding a reserve, if required.

4. L22-243 - Ouachita Parish, G.B. Cooley Hospital Service District

Not exceeding \$3,500,000 Certificates of Indebtedness, not exceeding 5%, not exceeding 10 years, acquiring, constructing, renovating, and equipping an existing building located at 1011 11th St. in Monroe, for the use of providing inpatient and outpatient behavioral health services.

Local Political Subdivisions - Bonds - Final Approval

5. L22-251 - Caddo Parish, Village of Ida

Not exceeding \$200,000 Sales Tax Revenue Bonds, not exceeding 6%, not exceeding 20 years, **(1)** acquiring, constructing, improving and maintaining a Town Hall/Community Center and **(2)** funding a debt service reserve fund, if necessary.

6. L22-254 - Caldwell Parish, Hospital Service District No. 1

Not exceeding \$5,000,000 Hospital Revenue Bonds, not exceeding 3.5%, mature no later than November 1, 2032, constructing and acquiring a rural health clinic including appurtenant equipment, fixtures and furnishings.

7. L22-250 - East Carroll Parish School Board

Not exceeding \$2,000,000 Revenue Bonds, not exceeding 6%, not exceeding 20 years, construction, improvement, rehabilitation and/or repairs of public school facilities, including equipping of school facilities.

8. L22-253 - Evangeline Parish Law Enforcement District

Not exceeding \$25,000,000 Sales Tax Revenue Bonds, not exceeding 5.5%, not exceeding 30 years, **(1)** acquiring, improving and constructing prison and operational facilities including the purchase of the necessary equipment and furnishings and **(2)** funding reserves, if necessary.

9. L22-235 - Franklin Parish, Town of Winnsboro

(1) Not exceeding \$715,000 Water Revenue Bonds, not exceeding 3%, not exceeding 40 years, **(a)** constructing and acquiring additions, extensions and improvements to its drinking water system, including, but not limited to comprehensive improvements to its drinking water supply, treatment, distribution and storage facilities and **(b)** funding a debt service reserve fund, if necessary and **(2)** not exceeding \$715,000 Bond Anticipation Notes, not exceeding 5%, mature no later than 18 months, interim financing.

10. L22-246 - Lafayette Parish, City of Lafayette

Not exceeding \$68,500,000 Public Improvement Sales Tax Bonds, not exceeding 6%, not exceeding 25 years, **(1)** purchasing, constructing, acquiring, extending and/or improving public works or capital improvements and **(2)** funding a reserve.

11. L22-247 - Lafayette Parish, City of Lafayette

Not exceeding \$50,000,000 Utilities Revenue Bonds, not exceeding 6%, not exceeding 30 years, **(1)** constructing and acquiring improvements and extensions, including necessary equipment and furnishings and **(2)** funding a reserve.

12. L22-248 - Lafayette Parish, City of Youngsville

Not exceeding \$9,000,000 Sales Tax Revenue Bonds, not exceeding 6%, not exceeding 20 years, **(1)** providing funding for the road improvement program, consisting of constructing and improving public streets, roads, alleys, sidewalks, and drainage facilities and **(2)** funding a reserve.

13. L22-245 - Lafayette Parish School Board

Not exceeding \$190,000,000 Sales Tax Revenue Bonds, not exceeding 6%, not exceeding 35 years, **(1)** constructing and acquiring capital improvements, including acquisition of lands for building sites and playgrounds, purchasing, erecting and improving school buildings and related facilities and acquiring necessary equipment and furnishings and **(2)** funding a reserve.

14. L22-249 - Orleans Parish, City of New Orleans, Sewerage and Water Board of New Orleans

Not exceeding \$45,000,000 Drainage System Limited Tax Bonds, not exceeding 5%, mature no later than December 1, 2028, constructing, improving, stabilizing, and extending the drainage system, excluding subsurface drainage systems, and its appurtenances.

15. L22-252 - Ouachita Parish, Walnut Street Economic Development District of the City of Monroe

Not exceeding \$3,200,000 Revenue Bonds, not exceeding 6.5% fixed or 10% variable rate, not exceeding 20 years, funding economic development projects including **(1)** renovation, improvement and rehabilitation of dilapidated or uninhabited buildings, **(2)** beautification of related property abutting said buildings, **(3)** provision of parking and creation of a hotel, restaurant, conference center and related facilities and **(4)** commercial office space and other relative facilities, including public utilities.
